



## Kingsford "Preserve the Pit" Search APPLICATION TERMS

## NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO APPLY FOR OR TO RECEIVE A FELLOWSHIP.

BY SUBMITTING AN APPLICATION, APPLICANTS AGREE TO THESE APPLICATION TERMS, WHICH CREATE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE APPLYING. WITHOUT LIMITATION, SUCH CONTRACT INCLUDES GRANTS OF RIGHTS AND INDEMNITIES TO THE SEARCH ENTITIES (AS DEFINED BELOW) FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

- 1. **Description of the Search:** Kingsford is committed to preserving the history of barbecue in the Black community in America and investing in future barbecue entrepreneurs. The Kingsford "Preserve the Pit" Search (the "Search") seeks to identify up to six (6) barbecue enthusiasts (i.e., aspiring restauranteurs, food truck chefs, influencers/bloggers, etc.) and provide them with support to help them learn the necessary skills and create a business plan to take their passion to the next level ("Fellowship").
- 2. **Eligibility:** This Search is open only to individuals who are legal residents and physically located in one (1) of the fifty (50) United States or the District of Columbia who are eighteen (18) years of age or older and at least the age of majority in their jurisdiction of residence at time of submission ("Applicant"). Although union or guild membership is not required to participate in the application process, individuals who are party to any union or guild agreement that would govern the creation of any materials in connection with a submission, including without limitation, SAG, AFTRA, and AFofM, are also eligible to participate. Void where prohibited or restricted by law.

The following are not eligible to participate or receive the Fellowship offered in the Search: 2021 and 2022 Fellowship recipients, employees, officers, or directors of the Kingsford Products Company, LLC, a subsidiary of The Clorox Company ("Kingsford") (located at 1221 Broadway, Oakland, CA, 94612), IPG DXTRA, Inc., dba Current Global ("Administrator") or their parent companies or affiliate and subsidiary companies, participating advertising and promotion agencies, and any company and affiliate and subsidiary companies associated with the Fellowship mentors (i.e., Howard Conyers, Pat Neely, Bryan Furman, Rashad Jones, Amy Mills, Kevin Bludso, Rasheed Phillips, and Devita Davison, collectively, the "Mentors"). Final eligibility and Mentor roster to be determined in Kingsford's sole discretion. Kingsford, Administrator, Mentors, and their respective parent companies and affiliate and subsidiary companies, participating advertising and promotion agencies, and each of its and their respective directors, officers, employees, agents, successors and assigns are collectively referred to herein as "Search Entities."

Note: Any Applicant's ability to participate in the Search or be selected as a Fellowship Recipient (as defined below) is subject to any/all applicable union rules. Kingsford will not be responsible for paying any required union membership fees, dues or other related charges. If considered by Kingsford to be a Fellowship Recipient, such participation will be subject to standard scale rates (if applicable).

- 3. **How to Apply:** To apply, visit **PreserveThePit.com** (the "Website") and complete the online application form, where Applicants will be asked to provide contact and other information, including a video, and answer the following questions (responses must be between 75-100 words):
  - What role does barbecue/grilling play in your life?
  - Why are you interested in the Preserve the Pit Fellowship program?
  - If selected, what are the goals that you would like to achieve with the help of the Fellowship?
  - How are you currently involved in the barbecue and/or restaurant industry? (i.e. business ownership, industry involvement, brand partnerships, etc.)
  - Barbecue has a special ability to create community. How will you use barbecue to continue that

legacy of community building?

• Tell us about your first and/or most meaningful barbecue memory.

Additionally, Applicants must upload a short video (between 1-3 minutes in length) through the Website that explains why they should be considered for the Fellowship Program, and addresses one (1) or more of the questions outlined above from the online form (online form and video together, "Application").

Applications must be submitted between February 28, 2023, at 12:00am Pacific Time ("PT") and 11:59pm PT on March 31, 2023 ("Submission Period"). Kingsford's designated clock is the official time clock of the Search. Application must include full and accurate contact information for Applicant. Application, including video, if submitted, must comply with the Submission Guidelines (defined below).

An Application may, in Kingsford's sole and absolute discretion, be rejected if it fails to follow the technical, creative, and legal requirements disclosed in these Application Terms. Those who do not follow all of the instructions, provide the required information in their Application, or abide by these Application Terms or other instructions of Kingsford may be disqualified in Kingsford's sole and absolute discretion. Search Entities are not responsible for Applications that are late, illegible, incomplete, damaged, destroyed, forged, inaccurate, delayed, misdirected or otherwise not in compliance with the Application Terms, and all such Applications may be disqualified from the Search in Kingsford's sole and absolute discretion. Applications generated by script, macro or other automated means or which subvert the submission process are void. Applications not selected will not be acknowledged. Assurance of delivery of Application is the sole responsibility of the Applicant.

- 4. **Submission Guidelines:** In addition to the provisions set forth herein, each Application must also comply with the following guidelines or will be subject to disqualification ("Submission Guidelines"):
  - a. Only one Application per Applicant.
- b. The Application must be in English (or in another language with English translation and/or subtitles).
  - c. The required video must be not less than sixty (60) seconds long and not longer than three (3) minutes in length.
- d. Subject to any applicable Coronavirus/COVID-19 travel restrictions, Applicants must be willing and able to travel between May and August 2023, in the event they are selected as a Fellowship Recipient. Specifically, Applicants must be able to travel for an in-person immersion session from May 17-20, 2023.
- e. Applications cannot be publicly displayed or distributed except by Kingsford and Applicants must maintain all rights, without third party obligations, to transfer the content of their Applications to Kingsford.
- f. In addition to the requirements set forth above, each Application must comply with the following:
  - I. The Application must be the Applicant's original work. The Application must not infringe the copyright, trademark, privacy, publicity, or other intellectual rights of any third party.
  - II. The Application must not contain any content or material that is lewd, obscene, sexually explicit, pornographic, disparaging, defamatory, libelous, obscene, violent, racist, derogatory of any ethnic, racial, gender, religious, professional or age group or otherwise

inappropriate or objectionable, as determined by the Expert Review Team (as defined below) and/or Kingsford in their sole and absolute discretion.

- III. The Application must not contain any personally identifiable information of any person other than the Applicant. Should the Applicant include personally identifiable information about him/herself in the Application, Applicant acknowledges and agrees that such information may be disclosed publicly, and Applicant is solely responsible for any consequences thereof.
- IV. The Application must not contain any clearly visible commercial content or logos of any entity other than Kingsford. For clarity, no use of Kingsford products is required.
- V. Applications cannot and will not promote any activity that is unsafe, hazardous, dangerous or prohibited by law. The Expert Review Team (as defined below) and/or Kingsford reserve the right to disqualify at any time any Application that they determine, in their sole and absolute discretion does not meet the requirements of the Application Terms or is inappropriate for any reason. Proof of submission of an Application does not constitute proof of receipt.
- VI. No background artwork should appear in the Application unless it is an original work of the Applicant. Any artwork, murals, etc. that can be seen in videos must be created solely by the Applicant or Applicant must be the sole owner of all copyright interests therein.
- VII. Videos with music may only include; 1) original music created and performed solely by Applicant (i.e., songs composed, lyrics written and performed by Applicant), or 2) music that is owned by a third party but has been licensed for such use by Applicant. Applications that include any other songs or recordings are in violation of these terms and will be subject to disqualification.
- VIII. The Applicant must have all rights, clearances, permissions, approvals and/or consents necessary from any other persons who participated in production of a video. In the event that an Applicant does not have the appropriate rights or violates any of the Submission Guidelines, the Application may be disqualified in Kingsford's sole discretion.
- Application Review: Application Review: After the conclusion of the Submission Period, all eligible Applications will be reviewed by a panel of barbecue industry experts selected by Kingsford ("Expert Review Team") who will evaluate the Applications based on a variety of factors, including without limitation the Applicant's (i) level of interest in the Fellowship program; (ii) commitment to the traditions of barbecue in the Black community; (iii) entrepreneurial spirit; and (iv) goals for future barbecue-related endeavors. The Expert Review Team may schedule interviews with Applicants as needed to assist with the review process. Exact date and time of interviews to be determined by the Expert Review Team, in their sole discretion. The Expert Review Team will select up to six (6) "Fellowship Recipients." Kingsford reserves the right to identify fewer than six (6) Fellowship Recipients in the event Kingsford does not receive a sufficient number of eligible and qualified Applications, as determined in their sole discretion. Application scores will not be revealed

## 6. Fellowship Recipient Notification Process:

- a. Each potential Fellowship Recipient will be notified by email or telephone on or about April 24, 2023. Within seven (7) days of Fellowship Recipient notification, each potential Fellowship Recipient must respond and confirm their acceptance of the Fellowship (subject to confirmation by Kingsford). Failure to respond during this time frame will forfeit the opportunity to proceed as a Fellowship Recipient and Kingsford may select an alternate Fellowship Recipient if time permits.
- b. Each potential Fellowship Recipient must also sign an Affidavit of Eligibility and Release of Publicity/Liability ("Affidavit and Release"), provide written consent for and pass a background screening,

and sign additional documents as required by Kingsford for their future participation as a confirmed Fellowship Recipient. Prior to being confirmed as a Fellowship Recipient, Fellowship Recipient may also be required to submit clearances and releases for all people, locations, service providers and media/content used within their video (if applicable). Failure to respond with all required documentation in a form acceptable to Kingsford within the required time period will forfeit the opportunity to receive the Fellowship. Kingsford may select an alternate Fellowship Recipient, if time permits.

7. **Fellowship (Up to six (6) awarded):** Each Fellowship Recipient will have the opportunity to learn skills from Kingsford-provided mentors and receive guidance in creating and maintaining business goals, as well as a monetary grant in the amount of \$15,000 at the conclusion of the Fellowship in approximately August 2023 ("Grant") to support their existing barbecue business.

Each Fellowship Recipient will also receive the following benefits and agree to actively participate in the following activities:

- Participation in not less than four (4) "Fellow Touch Bases" with the Mentors on a schedule that will be separately provided by Kingsford. All Touch Bases will be conducted by phone and will be thirty (30) to sixty (60) minutes in duration.
- Participation in immersion sessions with Mentors on dates and times mutually agreed upon by Fellowship Recipient, Mentors, and Kingsford. During the immersion sessions, Mentors will provide hands-on counseling to Fellowship Recipient. Total duration and locations of immersion sessions is to be mutually agreed upon by Fellowship Recipient, Mentors, and Kingsford.
- Potential participation and inclusion in select marketing activities to promote the Fellowship, as determined by Kingsford and the Mentors, in their sole discretion.
- Ongoing communication with Mentors and Kingsford throughout the duration of the Fellowship.

Fellowship Recipients acknowledge and agree that their active participation in the aforementioned activities is a key requirement of the Fellowship Program. If at any time during the Fellowship Program a Fellowship Recipient does not actively participate or becomes non-responsive to the Mentors, Administrator, or Kingsford, as determined by Kingsford in its sole discretion, they will forfeit their Grant and the opportunity to continue as a Fellowship Recipient, and Kingsford may select an alternate Fellowship Recipient if time permits.

Kingsford may document the Fellowship Recipient by any means, including by taking photographs, video recordings, and/or sound recordings. Fellowship Recipient consents to such activities and grants Kingsford and its partners and agencies permission to use, in perpetuity and by any means, the results of such activities for Kingsford's advertising and promotional purposes without additional compensation, unless prohibited by law. Fellowship Recipient's participation and services in connection with such activities shall be deemed a work-made-for-hire for Kingsford, as such term is understood in copyright law. In addition, acceptance of the Fellowship constitutes permission for, and Fellowship Recipients' consent to, Kingsford and its partners and agencies, and their respective successors, assigns and licensees, to use a Fellowship Recipient's name, photograph, voice recordings, biographical information and/or likeness and submission in any all forms of media and by any and all means (now and hereafter known), throughout the world, in perpetuity, for any purpose, including, without limitation, for advertising and promotional purposes, without any obligation, notice or additional compensation, unless prohibited by law.

All travel and lodging arrangements necessary for Fellowship Recipient to travel to an immersion session or barbecue event identified and approved by Kingsford will be made at Kingsford's cost and discretion and must be made through the Kingsford or Kingsford's designee. Certain travel restrictions may apply. Subject to applicable COVID-19 restrictions, the Fellowship Recipients must be available to travel and complete Fellowship tasks when designated by Kingsford or the Fellowship may be forfeited.

Approximate value of Fellowship benefits: \$24,000 per Fellowship Recipient. Actual value of Fellowship may vary depending on point of departure, travel dates and fare/rate fluctuations, if any.

Kingsford shall not be responsible for any cancellations, delays, diversions or substitution or any act or omissions whatsoever by the air carriers, hotels, venue operators, transportation companies, providers or any other persons providing any Fellowship-related services or accommodations. Kingsford is not liable for any missed Fellowship events, opportunities or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. No refund or compensation will be made in the event of the cancellation or delay of any transportation or other Fellowship element except at the sole and absolute discretion of Kingsford. Additional Fellowship details and travel information to be provided at the time of Fellowship notification.

Each Fellowship Recipient is responsible for obtaining travel insurance (and all other forms of insurance) at their option and hereby acknowledge that Kingsford has not and will not obtain or provide travel insurance or any other form of insurance. Fellowship Recipient may be required to provide a credit card at the time of hotel check-in. Travel (if applicable) is subject to the terms and conditions set forth in this Search, and those set forth by Kingsford's transportation carrier(s) of choice. Lost, stolen or damaged airline tickets, travel vouchers or certificates will not be replaced or exchanged.

All expenses not specifically mentioned herein are not included as part of the Fellowship, and are solely the Fellowship Recipient's responsibility, including, but not limited to: hotel taxes, additional ground transportation at the Fellowship Recipient's destination(s), travel insurance, room service, bag check fees, parking fees, laundry service, food, alcoholic beverages, merchandise, souvenirs, telephone calls, tips, gratuities and service charges. Transportation carrier and hotel regulations and conditions apply. Travel and lodging are subject to availability, and any changes made to either of these will be at the expense of the Fellowship Recipient.

Fellowship Recipients irrevocably waive all claims against the Search Entities and agrees that the Search Entities will have no liability or responsibility for any claim arising in connection with participation in this Search, the Fellowship provided, personal injury, or wrongful death, a potentially heightened risk of exposure to communicable diseases, viruses, bacteria or illnesses (including, without limitation, COVID-19) and the causes thereof, and sickness arising as a result of the Fellowship Recipient participating in the Search and related activities, wherever, whenever or however the same may occur. Fellowship Recipients fully understand that (a) the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, "COVID-19") is extremely contagious and there is an inherent risk of exposure to COVID-19 in any place where people are or have been present; (b) no precautions, including the protocols that will be implemented from time to time by any/all travel providers or those providing accommodations, can eliminate the risk of exposure to COVID-19; (c) while people of all ages and health conditions have been adversely affected by COVID-19, certain people have been identified by public health authorities as having greater risk based on age and/or underlying medical conditions; and (d) exposure to COVID-19 can result in being subject to quarantine requirements, illness, disability, other short-term and long-term health effects, and/or death, regardless of age or health condition.

An IRS Form 1099 may be issued in the name of Fellowship Recipient for the actual value of the Fellowship received.

Fellowship is non-transferable, with no cash redemption or substitutions except at Kingsford's sole and absolute discretion. All Fellowship details not specified in these Application Terms will be determined in Kingsford's sole and absolute discretion.

- 10. **Elimination:** Any false information provided within the context of the Search by any Applicant concerning identity, postal address, telephone number, ownership of rights or noncompliance with these rules or the like may result in the immediate elimination of the Applicant from the Search.
